

INTRODUCTION

In April 2021 the Board of Directors, on recommendation from the Academic Board, approved a new Research and Scholarship Strategy that addressed matters raised in TEQSA Guidance Notes on 'research' and 'scholarship' as well as changes to the Higher Education Standards Framework resulting from new Provider Category provisions in that legislation.

A key feature of the new Research and Scholarship Strategy is the collection into a repository of all publication outputs from ACT faculty and the subsequent categorisation of these outputs into the categories of Research and Scholarship. All Research (and almost all Scholarship) reported here is in the field of "Religious Studies" (ASCED 091703).

Outputs are classified as 'research' if they are determined to meet the Provider Category requirement of 'world standard', that is, if submitted to an Excellence in Research Australia (ERA) assessment (or similar process) they would be expected to be judged to be at least 'world standard'. The ACT Department of Research compiled a list of journals and publishers expected to meet ERA peer review 'world standard' and applied them to publication outputs, as well as reviewing individual outputs. Those that meet the criteria were categorised as 'research'. Other publications can be considered as 'confessional scholarship', in that the focus of the publication is scholarship that contributes to the life of the Church – see the Research and Scholarship Strategy for further discussion. The results of applying these criteria are presented in this 2020 Research and Scholarship Report. Summary data from 2016-2019, based on 2020 reclassifications, are provided in Appendix 1.

The list of journals and publishers is provided in Appendix 2 and will be updated as required in response to expert advice. The list was circulated to all faculty and HDR supervisors for their reference as they compile their research plans for 2021-2025, and the list and subsequent updates will be available to faculty and HDR candidates via the ACT website.

In Research there are four sub-categories: books , book chapters , journal articles , and refereed conference proceedings .








Research publications are all in the field of Religious Studies.

As part of its process to improve capture of research and scholarship outputs the ACT inaugurated a quarterly reminder to contributors to update their submissions. The re-classification process and additional submissions has increased both research and scholarship numbers, particularly for 2016-17 where past records were incomplete. APPENDIX 2 Guide to ACT-estimated ERA Rankings

The content of this appendix was approved by the ACT Board of Directors on 21 April 2021 as part of the Research and Scholarship Strategy (see Appendix B). A small number of entries have been updated following ongoing review.

Guide to ACT-estimated ERA Journal and Publisher Rankings

(✓ indicates ACT faculty publish in this Journal)

Excellence in Research for Australia (ERA) evaluations have occurred in 2010, 2012, 2015 and 2018 and the next round is planned for 2023. In the first round, journals were ranked as either A*, A, B, or C. The ranking of journals was discontinued for the 2012 and subsequent rounds, although lists of journals were published for each round. The ERA 2023 Journal List is yet to be published but is not expected to contain journal rankings.

The ERA evaluation does not rate individual journal articles or books or publishers but rates the overall output from an institution in a particular Field of Research (FoR). The rating is provided over broad fields (e.g. 22-Philosophy and Religious Education) and narrow fields (e.g. 2204-Religion and Religious Studies). A five-point rating scale is used, running from “well above world standard” to “well below world standard”.

Nevertheless, to provide a guide to ACT researchers, the following classifications are given to indicate the likely ERA rating that an article in a particular journal or a book with a particular publisher would contribute to. The classification is not definitive, as, for example, the quality of a journal can change with time, and the quality varies between articles in the same journal but serves as a guide as to where ACT researchers should be aiming to publish their research.
